Chairman's Letter

First of all I want to thank all those members who wrote to their MP's about the need for there to be a full and impartial investigation into alleged complicity of MI5 and MI6 in the abuse and torture of British subjects. Whether the letters were read by those in the corridors of power I don't know. But we will all, I'm sure, be delighted that there is to be an enquiry into these very important matters, and that it will be chaired by a judge.

Coincidence?

It was a coincidence (or was it?) that on the day of the last ACAT UK National Committee meeting (15th July) the headline in one national newspaper screamed 'TORTURE: the paper trail'. The report underneath gave details of the disclosure of hundreds of pages of classified documents revealing the UK's role in abuse and torture. The story will doubtless rumble on and we must wait, probably for many months, before the final report is published.

Meanwhile, the abuse and torture of individuals, young and old, men and women, continues and our mission as a small but influential charity to reduce and ultimately abolish torture must also continue.

Is there a difference?

People often ask me, and I imagine they often ask you, 'What is the difference between ACAT and the other organisations working for the abolition of torture, including Amnesty?' My answer is always the same: 'ACAT is a worldwide organisation working in over 38 countries, and we exist to expand the membership in churches who will campaign against the evils of torture.' I also often add that it baffles me (and it really does) that more Christians are not willing to join us in our campaigning, because it is true that abuse and torture are at the very centre of our faith in that Jesus suffered both for us.

Somehow, we as a charity, and I believe the church as a whole, have not got that message across. I believe it because if Christians in the churches did understand it and take it to heart, people would flock to join us. It was certainly the main reason for my joining ACAT.

'Wild Gospel'

I have recently been reading a new book entitled 'The Wild Gospel' by Alison Morgan. It is an inspirational volume and, although not dealing with abuse and torture, which is our particular brief, it looks very closely at today's culture, and must therefore include an acknowledgement that cruelty, violence, greed and torture are very much part of it.

In her Introduction Alison, writing about the power of Jesus as the Word of God, says this:

'As Christians we do not speak words of information. We speak words of truth, and therefore words of power; and like Jesus we don't just speak them we DO them.....Of ourselves, we can change nothing. But when we speak and live the truth, we find that our words and our deeds have the power of God Himself.'

I find that thought most encouraging. In our task of helping to abolish torture we, as Christians, can 'find that our words and our deeds have the power of God Himself'. With

that power within us we cannot fail. We must succeed, however small and frail we feel our efforts to be.

May I therefore encourage each of you to continue your campaigning and tell others within and without the churches of our aims, our successes and the divine power that inspires us.

May God richly bless you.

REMEMBER IN YOUR PRAYERS

The family of FERNANDO BALDOMERO, 61, PHILIPPINES, municipal councillor of Lezo, Provincial Co-ordinator of Makabayan Coalition-Aklan, Chairperson of Bayan Muba Party; he was shot in front of his house as he was about to take his 12 year old son to school; escaped an a grenade attack on his house in March.

ZOYA SAMADI, daughter in law of MANSOUR OSANLOO, President of the Syndicate of Workers of Tehran and Suburbs Bus Company, IRAN, serving 5 years in Raja'i Shahr Prison; she was attacked on June 23 at Tarasht metro station and beaten at an interrogation centre by agents of Ministry of Intelligence; she was left, after a 4 hour interrogation, at a bridge and was later admitted to hospital for treatment and suffered a miscarriage; Mansour Osanloo's health is very poor and he is in urgent need of hospital treatment; pray for his release and for his admittance to hospital.

ABUZAR AL AMIN, editor in chief, ASHRAF ABDELAZIZ, deputy editor, AL TAHIR ABU JAWHARA, head of the news desk, RAMADAN MAHJOUR, editor, newspaper Rai Al Shaab, SUDAN, arrested in May on charges of terrorism and espionage against the state; two were tortured following their arrest; the four are now on trial and could face the death penalty.

AZIMZHAN ASKAROV, KYRGYZSTAN, director of human rights organisation, Vozdukh (Air), part of a network in southern Kyrgyzstan, arrested 15 June in Bazar Kargon, Jalal-abad region; he has been targeted for his action as a human rights defender and subjected to prolonged beatings; his life is believed to be in danger.

HUMAN RIGHTS DEFENDERS, TRADE UNIONISTS, POLITICAL ACTIVISTS, SWAZILAND; using the draconian Suppression of Terrorism Act; there has been harassment, ill-treatment, arrest and torture; the law has been used to intimidate and silence opposition and all calls for democratic reforms.

CUBA - give thanks for the release of 52 political prisoners and prisoners of conscience, including some who have been included on the ACAT Christmas Greetings List in recent years.

NEWS ITEMS

FROM THE RUSSIAN FEDERATION

Further information about Oleg Orlov, Chairman of the Board of the Human Rights Centre, Memorial, based in Moscow. (Memorial also has centres in cities such as Grozny in Chechnya and in Ingushetia, Russian Federation). In October 2009, the Moscow Central Directorate of Internal Affairs opened a criminal investigation against Oleg Orlov relating to "libel" that the President of Chechnya initiated against him. He had indicated he believed the President responsible for the murder of Natalia Estemirova, Head of the Memorial Office in Grozny - ACAT took up this case. In February 2010 the President announced he was withdrawing the charges against Oleg Orlov but in June he was told the charges were still pending; on July 6 he was summoned to appear before the Investigation Division of the Department of Internal Affairs (Moscow) and charged. ACAT has campaigned on behalf of Memorial and also included it in prayers.

GOOD NEWS!

Emadeddin Baghi, Iran journalist and human rights defender, has been released on bail in June after spending almost 6 months in detention. (ACAT had taken up his case)

Turkey - 19 police officers and guards have been convicted of their part in the torture and death of Engin Ceber, human rights activist, in 2008 and sentenced to life imprisonment - this was a landmark victory.

The authorities in Cuba agreed recently, following negotiations with Spain and the Catholic Church, to release some 52 prisoners. Leading political opposition activists, community organisers and journalists, arrested in a crackdown on dissent in 2003 have been freed. Some had received sentences of anything up to 20 or 25 years. Spain has taken a number of those freed. Others have already been released in Cuba. Those arriving in Madrid included two who appeared on the Christmas Greetings lists for a number of years - Jose Luis Garcia Paneque and Pablo Pacheco. This is a policy shift for the Cuban Government and the largest liberation of prisoners since 1998 when 101 political prisoners were among 300 freed following the visit of Pope John Paul II.

12 people have been tried for abusing detainees at Kharizak detention centre, Iran, (closed following an international outcry) where under the use of torture last year, 3 detainees died; 2 staff were sentenced to death and 9 to prison and flogging; 1 was acquitted.

REPLIES

Members have received a number of replies in the last two months. My thanks to everyone who has sent in details and copies of letters. Replies have also been received in connection with SOS torture cases. The prosecutor's office of the Russian Federation continues to answer appeals, sending long replies in some instances - they seem to be replying to all appeals. One member has heard from the UK Government Counter Terrorism Department regarding the case of Shaker Aamer, British resident still held in Guantanamo and a small number have received replies via their M.P's concerning the question of UK complicity in torture.

Some More Good News

The national press is almost daily reporting on either torture and deaths taking place or the aftermath of torture and its effects on individuals and those who either practise it or appear to condone or ignore it.

BUT, here are two pieces of GOOD NEWS!

First, the charity Free Tibet recently reported that their campaign 'Stop Torture in Tibet' has had a success. On 3rd May China announced new regulations that make clear that Courts may not use:

Confessions extracted under torture in court proceedings
Testimonies extracted using violence or threats
Evidence whose origins are unclear

Second, one of our members, Stephanie Jefford, who is in touch with several prisoners on death row in Texas, writes:

Jonathan Green was not executed by the State of Texas as there was a stay granted on 30th June, just four hours before the execution was due to take place. There is to be a further evaluation of his case on mental health grounds. He suffers from delusional beliefs and severe mental illness.

Richard Dandy Smith's death sentence was commuted to a life term by the Governor of Oklahoma; another case of mental health issues plus an abused childhood.

On September 1st 2010 the 'Texas Office of Capitol Writs' becomes operational, set up by the legislature and to be headed by a defence lawyer from California. This office will defend 'indigents', i.e. the really poor folk who don't get a decent defence and those who say they were wrongly convicted.

That's surprisingly good news ---- for Texas!

Also, nationally, the US Senate is discussing a National Criminal Justice Commission to examine systemic flaws.'

IMPUNITY- DENIAL OF JUSTICE

Included in the May/June Newsletter was a small item of news about Baltasar Garzon, a leading Spanish judge, who had been disbarred and was likely to be prosecuted for seeking to set aside the 1977 amnesty law regarding atrocities committed at the time of the civil war and under the Franco regime. His name was also put on the Prayer Page.

ACAT received a letter from a long term member, very upset that Baltasar Garzon had featured in the Newsletter. I wrote back explaining ACAT's position regarding impunity. The member did not like my explanation and resigned. Shortly afterwards a letter from Spain arrived giving similar reasons why the amnesty laws should not be set aside and supporting the prosecution of Baltasar Garzon.

After discussion at a recent Committee Meeting, it was decided it was important to set out ACAT's position on impunity. This will be done in the next Newsletter.

ALLEGED COMPLICITY IN TORTURE - UK

As members will be aware, the Government has decided to set up an inquiry under Sir Peter Gibson, former appeal court judge and an intelligence services commissioner, who has monitored the work of MI5 and MI6 for several years. He will investigate the possible complicity of MI5 in torture. ACAT -UK has long campaigned for such an inquiry. There are however particular concerns over the appointment of Sir Peter Gibson and whether the inquiry will have sufficient authority and independence to ensure the full truth emerges. There are also concerns that new interrogation guidance for intelligence officers recently published, on the questioning of detainees held overseas, could still result in torture. The ACAT office has taken up both these concerns with the appropriate Government ministries; Reprieve has also take by the issue of the independence of Sir Peter Gibson. It is important to remember that under Article 4 of the UN Convention Against Torture complicity in torture is prohibited. There may also be problems concerning the calling of witnesses.

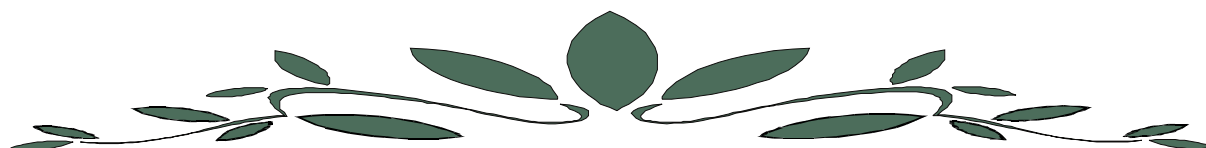

MEMBERS AND GROUPS PAGE

SALTASH

Saltash ACAT Group held a service on Saturday evening, 26th June, in a side chapel at the parish church. Fifteen of us gathered to sing and pray. It was led by Lesley Margetts, our Chairman, who drafted the service round eight stations of the cross. This was interspersed with hymns, prayers for the tortured, disappeared, torturers, human rights defenders etc. As in other years the names of individuals were included all during the service and a candle lit for each on a foil cross.

The lighting of the candles is always very emotive. It brings home to everyone present something of what it must be like to be imprisoned and tortured, or part of the family of someone who has suffered torture, has disappeared, or is a human rights defender threatened with death. After the service we all signed a card for our prisoner in Egypt, Mohammed Sharkawi. The candles were lit again for the Sunday morning service.

Terry and I read and prayed the Service of Prayer and Meditation and Prayer and Intercession at home late in the evening and then early on Sunday morning. It did not matter that there were only two of us. We felt very close to those for whom we were praying.

STOCKPORT

Ann Everett and a friend, who is a member of the Salvation Army in Heaton Norris, Stockport, asked if they could hold a vigil at the local Citadel; permission was given. Ann was ill and prayed at home but 3 people gathered together. Ann took one of the ACAT vigil booklets to All Saints Church, Heaton Moor Methodist Chapel, Wycliffe Church, the Evangelical Church and Heaton Chapel. She also sent information to the Society of Friends, to a friend in Dursley and to a relative in Oxford for their churches. She produced a form for people to sign giving times they were willing to pray at home and obtained several signatures.

DARLINGTON

David Rose has reported that the Vigil in a his Catholic church in Darlington was attended by 25 people, almost all after midnight, with one or two doughty souls there at 2.30, 4.00 and then at 6.00 am. Candles were burning throughout the night.

PETERBOROUGH

Timothy Fox has reported that a service was held at St Oswald's, Peterborough in the afternoon followed by Benediction. One of the services produced for the Vigil was used, with members of the congregation reading the prayers and meditations. From what he wrote, the service was a very moving occasion and appreciated by members of the congregation.

Again we held a vigil at St Mary Redcliffe Church in the City Centre. Many thanks are due to the Verger who set the porch for use. We had candles and tea lights lighting the area. members attended and we prayed for the tortured silently and contemplatively. We all felt very close to those who are suffering as a result of torture

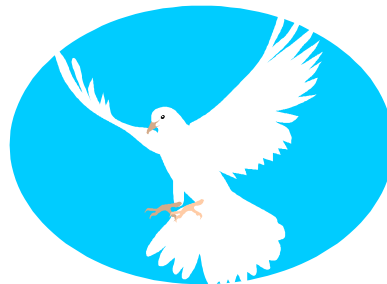
